#### I. <u>Call to Order</u>

- **A.** Chairman Jenkins called the meeting to order. The attending members constituted a quorum.
- B. Chairman Jenkins introduced himself as the Portage County engineer and the 2024 AMATS Policy Committee chair. Chairman Jenkins invited new Policy Committee members to introduce themselves. Mayors Sciliano-Kilway, Yeargin, and Mavrides introduced themselves.

#### C. Audience Participation

**Matt Stewart** presented comments from **Dave Mangold** regarding Greater Akron area rail corridors. Mr. Mangold made his comments during the Jan. 18 virtual meeting of the AMATS Citizens Involvement Committee.

In his comments, Mr. Mangold cautioned the region and its municipalities to not permanently give away or formally abandon any rail corridors that are not currently formally abandoned.

Mr. Mangold specified the Erie Lackawanna line (Freedom Trail) and the Akron Secondary line (Veterans Trail) as rail corridors that should not be abandoned.

Mr. Mangold stated that removing the possibility of rail service would be detrimental to the region's future economic competitiveness. Mr. Mangold expressed his support for the future of rail freight and possibly electrified commuter rail corridors.

Mr. Mangold noted that he is not opposed to recreational trails within rail corridors, but that he does advocate for rails *with* trails. Mr. Mangold noted that there are several examples of this across the nation.

Mr. Stewart said that an explanation regarding the downward trend was not readily available. Mr. Hadley asked if law enforcement data was available that could provide some insight regarding the peaks and valleys in totals. Mr. Stewart said that such data may not be available on a large scale.

Joe Paradise asked if inquiries could be made of ODOT as to whether the department is working on any projects within the identified high-crash sections and intersections. Mr. Stewart said that he was unaware of any ODOT projects. Ms. Prater noted that ODOT has a "hot-spot" analysis and maintains top lists of troublesome locations. #### I. <u>Welcome</u>

Matt Stewart welcomed the AMATS Citizens Involvement Committee (CIC) meeting attendees.

#### II. Discussion Items

**A.** Mr. Stewart presented Attachment 5A – *Traffic Crashes and Safety Performance Measures*.

Austen Rau asked whether the location of the Towpath Trail at the Riverview Road and Ira Road intersection contributed to the intersection's ranking as second in Table 2 - High Crash Intersections. The attendees discussed the intersection's ranking and other possible contributing factors at the four-way intersection such as the location of other pedestrian and at-grade rail crossings.

**Dave Mangold** asked if the report considered at-grade crossing accidents and the impact of roundabouts. **Mr. Stewart** said that the AMATS Staff is preparing a separate roundabout study. **Mr. Stewart** said that the agency has not conducted a comprehensive safety analysis of at-grade crossings, but noted that the agency has the capability to consider site-specific issues, such as at the Riverview and Ira road intersections.

**Mr. Mangold** stated that two at-grade rail crossings in Hudson now have whistle restrictions in which locomotive engineers may not blast their horns except during emergencies and when maintenance workers are present. **Mr. Mangold** said that the Ohio Rail Development Commission (ORDC) recently provided the local matching funding for the construction of the Hines Hill Road Overpass in Hudson.

**Mr. Mangold** asked if there were any rail-related crash fatalities within the Greater Akron area in 2023. **Curtis Baker** said that there were no rail-related fatalities.

B. Mr. Stewart presented Attachment 6A – Resolution 2024-01 – Approving Projects to be Funded under the Carbon Reduction program (CRP); Resolution 2024-02 – Approving Projects to be Funded under the Resurfacing program; Resolution 2024-03 – Approving Projects to be Funded under the Transportation Alternatives Set Aside (TASA) program; and Resolution 2024-04 – Approving Transportation Alternative Set Aside Supplemental Project List for Possible Future Funding.

**Mr. Rau** praised the funding of three TASA projects. **Mr. Rau** asked if the \$1.1 million in TASA funding for the Rubber City Heritage Trail Phase 3 in Akron was correct. **Mr. Rau** asked if \$1 million in TASA funding was the maximum amount permitted for projects. **Mr. Baker** explained that Mr. Rau was correct about the maximum amount of TASA funds being limited to \$1 million, but noted that the total listed included funding from the AMATS Project Delivery Incentive Program (PDIP).

C. Matt Mullen presented Attachment 5B – Active Transportation Plan Update.

**Mr. Rau** asked if the *Active Transportation Plan* update would include a public comment period. **Mr. Stewart** said that a draft Shared-Use Map would be available for public review and comment in a web-based app. The agency is first preparing a web portal for communities to share their comments and insights on the map. The public will be asked to react to these map additions and also provide their own. This should occur in March. **Mr. Stewart** said that AMATS will include received map comments into the draft *Active Transportation Plan* to be presented to the AMATS Policy Committee in May.

- Mr. Mangold cautioned the Greater Akron area and its municipalities to not permanently give away or formally abandon any rail corridors that are not currently formally abandoned. Mr. Mangold stated that removing the possibility of rail service would be detrimental to the region's future economic competitiveness. Mr. Mangold expressed his support for the future of rail freight and possibly electrified commuter rail corridors. Mr. Mangold noted that he is not opposed to recreational trails within rail corridors, but that he does advocate for rails with trails. Mr. Mangold noted that there are several examples of this across the nation. Mr. Mangold requested that his comments be submitted to the AMATS Policy Committee. Mr. Stewart said that he would do so.
- E. Mr. Rau asked if TASA funding would be held by AMATS for two Veterans Trail projects. Mr. Baker said that the TASA funding is secure. The attendees discussed funding scenarios for the trail projects.

#### III. Adjournment

There being no other business, the meeting was adjourned. The next meeting of the CIC is scheduled for **6:30 p.m.** on **Thursday, March 21, 2024**.

AMATS is almost three-quarters of the way through Fiscal Year 2024 and approximately 78% of all STBG project funding has been encumbered. STBG funds are overbudgeted by approximately \$1.4 million and AMATS is already discussing a loan with ODOT, so that the remaining FY 2024 STBG projects can be sold on time. TASA funds are underbudgeted by \$419,463 and CRP has no funds programmed in FY 2024. CRP funds will continue to carry over into future years. CMAQ funds are budgeted at the statewide level so that balance should not be an issue locally.

As the agency prepares to begin the fourth quarter of the fiscal year, AMATS still has five STBG projects to sell. One of AMATS' largest STBG projects in FY 2024, the Wooster Rd West Reconstruction, was awarded on 3-1-24. Two projects still have right-of-way money in FY 2024, but that funding may move to construction in future years.

CMAQ still has one construction project to sell, and TASA has one right-of-way phase and three construction phases to be encumbered.

The AMATS committees are expected to review and approve STBG projects later at this meeting. Those projects will be added to the funding sheets as they are programmed with ODOT. CMAQ, CRP, TASA, and Resurfacing projects that were approved in the last few months have been added to the funding sheets and PID numbers are added as they are programmed with ODOT. Please remember to submit these projects to ODOT if you haven't already done so.

RE: 2024 Active Transportation Plan Draft Recommendations
DATE: March 7, 2024

AMATS Staff is currently developing the 2024 Active Transportation Plan (ATP), which will inform the next long-range transportation plan, *Transportation Outlook 2050*. This plan will present the various strategies and recommendations that the agency will pursue to improve the Greater Akron area's bicycle and pedestrian networks.

In November, Staff created an interactive map of the current bicycle network and requested assistance from member communities in capturing updates to the network since the 2019 *ATP*. In January, a listing of future Shared Use Paths was updated with the assistance of member communities, as well as several townships and community organizations within the AMATS area. Finally, an interactive map of these future Shared Use Path projects in combination with the current bicycle network was created and made available for public comment. The Citizens Involvement Committee will be invited to provide comments at their March 21, 2024 meeting. The public comment period will close on March 22, 2024.


As a result of this outreach and collaboration, Staff has accumulated a draft listing of future shared use path projects, as well as goals and strategies to be incorporated into the *ATP*. Attached is the listing of shared use path recommendations and its accompanying map. In addition, the Goals and Strategies Matrix lists the specific infrastructure and outreach goals that the agency will pursue to promote accessibility, efficiency, and safety of the area's networks. In addition to increasing the infrastructure available for cyclists and pedestrians in the AMATS area, the agency strongly encourages safety improvements for some of our most vulnerable users.

The outline for the final Active Transportation Plan is attached. Staff anticipates bringing the final draft of the ATP to Policy for approval in May.

AMATS is working on an areawide roundabout study. Among other topics, the study will assess the safety performance of 28 existing roundabouts along roadways eligible for AMATS funding. AMATS staff expect to bring this study before AMATS committees in May for approval.

#### **Report Components**

An abridged version of the plan's draft outline is shown on the following page.

The body of the report will include three chapters. Brief introductory and concluding chapters will bookend the main content for a total of five chapters.

Chapter Two, *Roundabout Characteristics*, begins by defining roundabouts and describing the different types of roundabouts. The chapter then covers numerous advantages and disadvantages, siting considerations, best practices and issues regarding signage, typical costs, and other key considerations.

Chapter Three, *AMATS Roundabouts*, will be the most comprehensive chapter of the report. The chapter begins by laying out a large inventory of existing and planned roundabouts on AMATS roadways, traffic circles, privately owned roundabouts, roundabouts on local streets, and neighboring roundabouts outside, but close to the AMATS planning boundary. Comprehensive data were collected for each of these roundabouts and traffic circles. The latter part of the chapter includes individual sheets for each of the 28 existing roundabouts, complete with pre-and-post imagery, specifications of the roundabout, and crash performance of each roundabout. Staff has gathered the crash data for each roundabout, including total crashes by level of severity for each year from 2012-2022. Because some of the area's roundabouts were built prior to 2012, we also have older data on hand for these locations; the data just doesn't line up the same way as post-2012 data does. Still to be determined is the full pre vs. post roundabout crash comparison analysis, so that it can be determined for each roundabout and collectively, across the region, how they are performing post-construction vs. pre-roundabout.

Chapter Four, *Planning for Roundabouts in the Greater Akron Area*, will include local government planning considerations and best practices and funding considerations.

Before staff concludes the writing of this draft report, staff is asking AMATS Committees to consider the following:

- 1. Please review the attached *Inventory of AMATS Area Roundabouts and Traffic Circles* document and provide any changes to AMATS.
- 2. Consider sharing any positive or negative experiences on how your community has navigated while planning and constructing roundabouts, including public outreach, or lessons learned over time. Our staff is aware of many of the lessons learned over the past 15 years, but we would welcome any additional commentary that can help inform Chapter Four of our plan.

The AMATS Policy Committee administers the Surface Transportation Block Grant (STBG), funding program. This flexible program provides much needed funds for area highway, bike and pedestrian projects. As part of administering these funds, the Policy Committee has assigned the TAC-TIP Subcommittee the responsibility of reviewing and maintaining a viable program and to make recommendations to the Policy committee as needed. Staff assistance is provided to the TAC-TIP Subcommittee in performing these duties.

The TAC-TIP Subcommittee met on December 6, 2023 and January 18, 2024, to review the recently submitted project applications, approve evaluation criteria, and develop a list of project recommendations for STBG program. These projects will be added to the 2024-2027 Transportation Improvement Program (TIP) or to the next TIP depending on the project schedule.

#### Surface Transportation Block Grant (STBG) Recommendations

The attached Table 1 summarizes all 26 projects that were submitted under the STBG funding program. Total funding requested through the STBG program was approximately \$85.6 million. Three projects, totaling approximately \$15.2 million, are being recommended for funding and are listed in bold type on the table. The project summary includes total project scores based on criteria contained in AMATS Funding Policy Guidelines.

#### Staff Comments

As with all AMATS project decisions, considerations with respect to public involvement, financial capability, environmental justice, and air quality are important.

#### **Public Involvement**

One of the eligibility requirements for funding projects with AMATS suballocated funds is that the project be included in the Regional Transportation Plan. All projects recommended for funding are consistent with the Plan, which gives priority to preserving the existing transportation system, and have therefore gone through public involvement in accordance with AMATS Public Participation Plan.

This process includes a notification in the Akron Beacon Journal that these resolutions will be presented for comment at a Citizens Involvement Committee meeting scheduled for March 21, 2024. Any comments on these projects will then be forwarded to the Policy Committee meeting on March 28.

#### **Financial Capability**

Newly selected projects will be programmed in fiscal years towards the end of the current TIP or beyond. These new projects will be programmed in FY 2026-2029. Trading funds with other MPOs may be pursued to possibly advance some projects.

#### **Environmental Justice**

These projects have gone through an environmental scan as part of the development of the Regional Transportation Plan and do not have any adverse environmental impacts on minorities and/or low-income people.

#### Air Quality

Finally, all selected projects can be viewed as exempt from air quality and are in compliance with the Clean Air Act.

#### **STAFF RECOMMENDATIONS**

Attached to this memo is Resolution Number 2024-07 approving projects to be funded under the STBG program and included in the Transportation Improvement Program FY 2024-2027 where applicable. The TAC TIP Subcommittee and Staff recommend approval.

- **DATE:** March 28, 2024

The following changes have been requested to the FY 2024-2027 Transportation Improvement Program:

#### Revise funding

- SUM-East Ave (PID 112869) Is a project that includes adding a two-way left turn lane, curbs, and sidewalks along East Ave from Community Rd to the Portage County Line. This project moved from the "group" list to the "individual" list when phase 1 received \$8,509,995 in CMAQ construction funding for FY 2028. The total project cost has also been increased to almost \$14 million.
- SUM-IR 77/SR 8-11.65/0.00 (PID 114865) Is a project for corridor improvements along IR 77 just north of Lovers Lane to SR 8 and SR 8 from IR 77 to just north of Perkins St including ramp and service road reconfigurations to increase safety and reduce congestion. This project is being revised to add right-of-way money into FY 2025 in the current Transportation Improvement Program. Construction is tentatively scheduled to begin in FY 2029 but is not currently funded.
- 3. SUM-S Arlington Rd (PID 116917) Is a project to widen South Arlington Rd from Boettler Rd to north of September Dr from 2 to 4 lanes in Green, Ohio. This project includes adding roundabouts at Boettler Rd and Southwood Dr. It also includes adding new sidewalks and a multi-use path along the corridor. \$2 million in carbon reduction program funds and \$3.5 million in highway safety funds have been added to this project in the construction phase. This project is expected to begin construction in FY 2026.

#### New projects

- 4. WAY-Doylestown Rd (PID 116855) Is a resurfacing project in Wayne County on Doylestown Rd from Rittman east corporation limit to Doylestown west corporation limit and Portage St from Whitman Rd to Doylestown west corporation limit. This project includes \$508,829 of STBG construction funding in FY 2027.
- 5. SUM-SR 532 & Albrecht Ave (PID 120494) Is a project to add a new signal at the intersection of SR 532 and Albrecht Ave in Mogadore. This project includes \$4,800 of CMAQ right-of-way funds in FY 2027.
- 6. **SUM-Highland Rd (PID 121067)** Is a project the add new signals at SR 8/Highland Rd and Highland Rd/South Bedford Rd. It is also adding an addition westbound left turn lane at SR 8, a southbound right turn lane at South Bedford Rd, and a new sidewalk along South Bedford Rd. This project includes \$213,600 of CMAQ right-of-way monies in FY 2027.
- SUM-Killian Rd/Pickle Rd Roundabout (PID 121287) Is a project that reconstructs the Killian Rd/Pickle Rd intersection into a roundabout, improves sight distance on the eastern approach, and adds sidewalks. This project includes \$240,000 of CPR right-of-way monies in FY 2027.
- 8. **POR-North Mantua St Improvements (SR 43) (PID 121376)** Is a project for corridor improvements along SR 43 between Needham Ave to north of Davey Tree Entrance. This project includes \$2 million of CRP construction funding in FY 2027.
- 9. SUM-Graham Rd Signals (Stow) (PID 121457) Is a project that replaces and upgrades nine signals on Graham Rd between Bailey Rd and Newcomer Rd in Stow. This project includes \$2,860,000 of CMAQ construction funding in FY 2027.

## STAFF COMMENTS

As with all TIP amendments, considerations with respect to public participation, financial capability, air quality, environmental justice and Plan consistency are important. Sufficient funding is forecasted from federal and state sources for this amendment. The projects listed meet all the amendment requirements mentioned above. Therefore, this amendment does not cause any negative impact.

#### **STAFF RECOMMENDATION**

Attached to this memo is Resolution Number 2024-08. This Resolution approves the amendment to the FY 2024-2027 TIP. The Staff recommends approval.

#### OF THE METROPOLITAN TRANSPORTATION POLICY COMMITTEE OF THE AKRON METROPOLITAN AREA TRANSPORTATION STUDY

Approving Amendment #5 to the FY 2024-2027 Transportation Improvement Program to revise funding for three projects and add six new projects.

**WHEREAS**, the Akron Metropolitan Area Transportation Study (AMATS) is designated as the Metropolitan Planning Organization (MPO) by the Governor, acting through the Ohio Department of Transportation and in cooperation with locally elected officials in Summit and Portage Counties and the Chippewa Township and Milton Township areas of Wayne County; and

**WHEREAS**, it is the responsibility of this Committee to develop and maintain the Transportation Improvement Program (TIP); and

**WHEREAS**, this Committee has been requested to amend the AMATS FY 2024-2027 Transportation Improvement Program to revise three projects and add six new projects:

- SUM-East Ave (PID 112869) Is a project that includes adding a two-way left turn lane, curbs, and sidewalks along East Ave from Community Rd to the Portage County Line. This project moved from the "group" list to the "individual" list when phase 1 received \$8,509,995 in CMAQ construction funding for FY 2028. The total project cost has also been increased to almost \$14 million.
- 2. SUM-IR 77/SR 8-11.65/0.00 (PID 114865) Is a project for corridor improvements along IR 77 just north of Lovers Lane to SR 8 and SR 8 from IR 77 to just north of Perkins St including ramp and service road reconfigurations to increase safety and reduce congestion. This project is being revised to add right-of-way money into FY 2025 in the current Transportation Improvement Program. Construction is tentatively scheduled to begin in FY 2029 but is not currently funded.
- 3. SUM-S Arlington Rd (PID 116917) Is a project to widen South Arlington Rd from Boettler Rd to north of September Dr from 2 to 4 lanes in Green, Ohio. This project includes adding roundabouts at Boettler Rd and Southwood Dr. It also includes adding new sidewalks and a multi-use path along the corridor. \$2 million in carbon reduction program funds and \$3.5 million in highway safety funds have been added to this project in the construction phase. This project is expected to begin construction in FY 2026.
- 4. WAY-Doylestown Rd (PID 116855) Is a resurfacing project in Wayne County on Doylestown Rd from Rittman east corporation limit to Doylestown west corporation limit and Portage St from Whitman Rd to Doylestown west corporation limit. This project includes \$508,829 of STBG construction funding in FY 2027.

- SUM-SR 532 & Albrecht Ave (PID 120494) Is a project to add a new signal at the intersection of SR 532 and Albrecht Ave in Mogadore. This project includes \$4,800 of CMAQ right-of-way funds in FY 2027.
- 6. SUM-Highland Rd (PID 121067) Is a project the add new signals at SR 8/Highland Rd and Highland Rd/South Bedford Rd. It is also adding an addition westbound left turn lane at SR 8, a southbound right turn lane at South Bedford Rd, and a new sidewalk along South Bedford Rd. This project includes \$213,600 of CMAQ right-of-way monies in FY 2027.
- SUM-Killian Rd/Pickle Rd Roundabout (PID 121287) Is a project that reconstructs the Killian Rd/Pickle Rd intersection into a roundabout, improves sight distance on the eastern approach, and adds sidewalks. This project includes \$240,000 of CPR right-of-way monies in FY 2027.
- 8. POR-North Mantua St Improvements (SR 43) (PID 121376) Is a project for corridor improvements along SR 43 between Needham Ave to north of Davey Tree Entrance. This project includes \$2 million of CRP construction funding in FY 2027.
- 9. SUM-Graham Rd Signals (Stow) (PID 121457) Is a project that replaces and upgrades nine signals on Graham Rd between Bailey Rd and Newcomer Rd in Stow. This project includes \$2,860,000 of CMAQ construction funding in FY 2027.

**WHEREAS**, the necessary public involvement has been fulfilled as described in the AMATS Public Participation Plan; and

**WHEREAS**, it has been determined that the S Arlington Rd project is not exempt from regional air quality conformity analysis and has been analyzed for air quality conformity. An air quality conformity determination that addresses both ozone and PM<sub>2.5</sub> pollutants has been conducted and has shown that the projects will conform to air quality requirements; and

**WHEREAS**, interagency consultation has occurred on February 22, 2024 and all planning partners concur to use current conformity determination due to no scope changes for this project; and

**WHEREAS**, the environmental justice impacts of this amendment has been considered consistent with "Executive Order 12898 Federal Actions to Address Environmental Justice in Minority Populations and Low Income Populations"; and

**WHEREAS**, this Committee has analyzed this request and found this amendment to be consistent with Transportation Outlook 2045, the Regional Transportation Plan, and with the availability of federal funds forecasted for the AMATS area.

#### **RESOLUTION NUMBER 2024-08 (Continued)**

#### NOW THEREFORE BE IT RESOLVED:

- 1. That this Committee amends the Transportation Improvement Program FY 2024-2027 as previously specified.
- 2. That this Committee considers the necessary public involvement has been carried out as described in the AMATS Public Participation Plan.
- 3. That this Committee affirms that sufficient federal funding is expected to be available for the Akron Urbanized Area to maintain financial constraint.
- 4. That this Committee reaffirms the air quality conformity determination in the AMATS Transportation Improvement Program FY 2024-2027 and its consistency with Transportation Outlook 2045, the Regional Transportation Plan.
- 5. That this Committee affirms conformity with environmental justice requirements.
- 6. That this Committee affirms consistency with Transportation Outlook 2045, the Regional Transportation Plan.
- 7. That this Committee authorizes the Staff to provide copies of this Resolution to the appropriate agencies as evidence of action by the Metropolitan Planning Organization.

As part of the Connecting Communities Initiative, AMATS developed a grant program that made grant funding available for planning studies. In January 2024, AMATS solicited applications for the grant. AMATS received eight applications prior to the February 9, 2024 deadline. Per the application, these planning studies should further the following Connecting Communities Principles:

- Increase alternative transportation options to connect people and places
- Promote Complete Street principles to create vibrant and safe places for all users
- Leverage transportation projects/funding to develop places which support alternative transportation and complete streets through land use and design

The AMATS staff initially met to score and discuss the applications. The Connecting Communities Planning Grant Task Force met on February 22, 2024 to review the applications and recommend award recipients. The Task Force recommends awarding the planning grants to the city of New Franklin's "SR 619 Corridor Development Planning Study" and to the city of Akron's "Summit Lake Pedestrian Safety Master Plan". The Task Force based this recommendation on each application's scope and objectives, its adherence to the Connecting Communities Principles, and the recommendation of the AMATS staff.

Attached to this memo are scores for all of the applications and a more in-depth description of the proposals submitted by the top two applicants.

The staff and the Connecting Communities Planning Grant Task Force recommend the Policy Committee approve Resolution 2024-09 awarding a Connecting Communities Planning Grant to the city of New Franklin's "SR 619 Corridor Development Planning Study" and the city of Akron's "Summit Lake Pedestrian Safety Master Plan".

Approving two Connecting Communities Planning Grants to be awarded to the city of New Franklin and the city of Akron for planning studies.

**WHEREAS**, the Akron Metropolitan Area Transportation Study (AMATS) is designated as the Metropolitan Planning Organization (MPO) by the Governor, acting through the Ohio Department of Transportation (ODOT) and in cooperation with locally elected officials in Summit and Portage Counties and the Chippewa Township and Milton Township areas of Wayne County, and

**WHEREAS**, the Connecting Communities Planning Grant was included under work element 625 and approved as part of the *Transportation Planning Work Program and Budget FY 2024* and will be funded using Federal Consolidated Planning Grant monies, and

**WHEREAS**, the purpose of these grants is to encourage the integration of land use and transportation planning and promote livable communities,

**WHEREAS**, the AMATS Policy Committee, on August 11, 2010, approved the formation of a Connecting Communities Planning Grant Task Force to score applications, and

**WHEREAS**, AMATS received eight applications requesting funding prior to the deadline of February 9, 2024, and

**WHEREAS**, the Connecting Communities Planning Grant Task Force met on February 22, 2024 to review submitted applications and the staff's preliminary scoring, and

**WHEREAS**, upon review of all applications, the Connecting Communities Planning Grant Task Force recommended the following two applications for funding:

- 1. City of New Franklin: SR 619 Corridor Development Planning Study in anticipation of a new residential development and the introduction of water and sewer, a study of the SR 619 corridor between S. Main St. and State St. with solutions to accommodate all modes of transportation is needed.
- 2. City of Akron: Summit Lake Pedestrian Safety Master Plan –with recent investment in the Summit Lake neighborhood, there is an increased need to address pedestrian safety for the visitors to the area. The study should improve safety while enhancing walkability through complete street principles.

**WHEREAS**, this Committee has found these applications to be consistent with the *Connecting Communities Initiative - A Guide to Integrating Land Use and Transportation*.

#### NOW THEREFORE BE IT RESOLVED:

- 1. That this Committee approves the funding of the city of New Franklin's SR 619 Corridor Development Planning Study and the city of Akron's Summit Lake Pedestrian Safety Master Plan Study.

- 3. That this Committee affirms consistency of these two applications with *Connecting Communities* – *A Guide to Integrating Land Use and Transportation*, and *Transportation Outlook*, the area's long range transportation plan.
- 4. That this Committee authorizes the staff to provide copies of this Resolution to the appropriate agencies as evidence of action by the Metropolitan Planning Organization.

# 2024 Planning Grant

#### City of New Franklin's SR 619 Corridor Development Planning Study

State Route 619 between the city of Green to the east and State Street to the west is ripe for development. A new residential development is planned near the intersection of SR 619 and Point Comfort Drive, as is the extension of water and sewer to the SR 619 corridor. These developments promise hundreds of new residents and a need to support additional growth. The corridor currently sees 10,000 cars daily, in addition to bike and pedestrian traffic. Currently, there are no safe facilities for pedestrians and cyclists, and the city of New Franklin, being proactive, desires a plan to provide recommendations for multiple modes of transportation. Improvements should include, but are not limited to, bike paths, sidewalks, crosswalks, and lighting.

### City of Akron's Summit Lake Pedestrian Safety Master Plan

Following the "Our Summit Lake Land Use" planning process, a need was identified to increase safety for all modes of transportation in the Summit Lake neighborhood. With new amenities and increased investment drawing users to the area, as well as speeding traffic creating a hazard for active transportation, it is crucial to address pedestrian safety for persons of all ages and abilities. The Summit Lake Pedestrian Safety Master Plan will identify a framework for integration and development of complete streets principles to be utilized as the neighborhood grows. The city of Akron anticipates recommendations such as bike lanes/boulevards, improved crosswalks, curb bump outs, on-street parking, and speed tables.
