### **Meeting Summary**

### I. Welcome

Matt Stewart welcomed the AMATS Citizens Involvement Committee (CIC) meeting attendees.

### **II.** <u>Discussion Items</u>

**A. Mr. Stewart** summarized the development of the AMATS Area Coordinated Public Transit – Human Services Transportation Plan. **Mr. Stewart** described the agency's engagement strategies with the public and area transportation stakeholders during development of the plan. These strategies included an online survey, phone surveys, outreach to transportation providers, and assembling a planning committee.

**Mr. Stewart** noted key changes between the 2023 plan and the 2018 plan. **Mr. Stewart** said that the planning process revealed gaps in area public transit service and reviewed the plan's recommendations to address these gaps.

William Maki discussed how potential transit users are made aware of services available to them. The attendees discussed potential assistance and travel-training programs available to the public and how to access them.

**B.** Curtis Baker presented Attachment 4A – AMATS 2023 Funding Policy Guidelines.

**Austen Rau** asked if AMATS had received any inquiries from communities regarding Transportation Alternatives Set-Aside (TASA) funding for projects. **Mr. Baker** said that city of Akron officials indicated that the city would seek funding for the Rubber City Heritage Trail. **Mr. Baker** said that officials from Portage County, the Village of Boston Heights, the Summit Metro Parks, and the city of Hudson have

expressed interest in TASA funding, but no formal applications have been submitted to AMATS.

**Mr. Rau** said that the Trail Advocates of Summit County (TASCforce) have prepared a proposal in which the communities of Cuyahoga Falls and the Village of Silver Lake would seek TASA funds to complete the southern portion of the Veterans Trail, which would link the state Route 8 pedestrian bridge to the Riverfront Park pedestrian bridge. **Mr. Rau** said that Cuyahoga Falls officials indicated that they did not intend to seek funding, but village officials are considering the proposal for the portion of the project located within Silver Lake. The attendees discussed the TASCforce proposal.

**Mr. Rau** asked what sort of projects that communities seeking Carbon Reduction Program (CRP) funds are proposing. **Mr. Baker** said that CRP may be an ideal source to fund roundabout projects because they are the highest priority for CRP funding and because they typically are effective at significantly reducing carbon emissions compared to other intersections. The attendees then discussed the benefits of roundabouts.

**Mr. Rau** asked for a description of the roundabout project for which the city of Cuyahoga Falls is seeking Congestion Mitigation Air Quality (CMAQ) funding. **Mr. Baker** said that the roundabout project proposed in the city's CMAQ application would be located at the intersection of State and Quick roads and would include a two-way, left-turn lane extension on Old Route 8 to the border of the Village of Boston Heights.

**Mr. Baker** said that AMATS will share information regarding funding applications received by the agency with the TASCforce upon request.

- C. Mr. Stewart described the AMATS-sponsored Sept. 23 Bike-N-Brainstorm in Akron's Middlebury neighborhood.
- **D. Heather Davis Reidl** promoted the statewide Gohio Commute Challenge.

### III. Adjournment

There being no other business, the meeting was adjourned.

Since the beginning of the fiscal year both planning programs have been authorized, two projects have sold (Barberton and Ravenna), two curb ramp funding projects have sold (Stow and Ravenna) and two right-of-way phases have been authorized (Twinsburg and Macedonia). Please note that the FY 2025 CRP funds show a negative balance; however, FY 2024 funds should carryover to more than cover that negative balance. CRP funds can't be recalled like STBG and TASA funds.

CMAQ projects have been selected and should be approved later in this meeting. Once approved, project sponsors will be sent award letters with detailed information such as the amount and year to be programmed. Then, sponsors will need to contact ODOT to get these projects a PID so they will be in the system.

STBG, resurfacing, TASA, and CRP funding applications have been scored and reviewed by TAC/TIP subcommittee and scores will be presented later in this meeting. Final selection of these projects should be approved in January.

and Transportation Alternatives Set Aside (TASA) Program.

DATE: December 14, 2023

Funding applications for new STBG, Resurfacing, CRP and TASA projects were received by AMATS by November 3. A total of 118 applications were submitted and 4 applications were disqualified or withdrawn before scoring. We appreciate all the sponsors who submitted applications. As usual the demand for funding has far exceeded the amount that is available.

The TAC TIP Subcommittee met on December 6th to review the recently submitted applications and the points that were awarded to each project. The project summaries include total project scores based on criteria contained in AMATS Funding Policy Guidelines. These lists are for your review only. Formal approval is planned at our January meetings. Please let us know if you have any concerns that we can discuss with you before formal approval. Once approved, the projects will be added to a future Transportation Improvement Program (TIP) as they will probably be programmed beyond the 2024-2027 TIP timeframe.

### **Surface Transportation Block Grant (STBG)**

The attached Table 1 summarizes all 26 projects that were scored under the STBG funding program. A total of \$89.1 million of STBG funding was requested and \$15.0 million is available. These are typically larger projects with an average request of nearly \$3.3 million. With a maximum request of \$6.0 million allowed, \$6.1 million with PDIP, these funds are used up quickly.

### **Resurfacing Program**

The attached Table 2 summarizes all 42 projects that were scored under the Resurfacing program. A total of \$32.2 million of resurfacing funding was requested and \$15.0 million is available. This ratio will enable AMATS to fund many of the new resurfacing projects. The average request was \$766,858. The maximum allowable request is \$800,000, \$900,000 with PDIP. This program is very popular for both large and small communities in our area.

### **Carbon Reduction Program (CRP)**

The attached Table 3 summarizes all 17 projects that were scored under the CRP program. A total of \$23.7 million of CRP funding was requested and \$8.0 million is available. The average request was approximately \$1.4 million. The maximum allowable request is \$2 million.

### **Transportation Alternatives Set Aside (including supplemental)**

The attached Table 4 summarizes all 23 projects that were scored for TASA funding program. A total of \$17.6 million was requested for TASA funding while only \$1.2 million is available. The average request was \$765,636.

Table 5 includes six TASA supplemental projects. A total of almost \$3 million was requested for TASA supplemental funding while availability is uncertain. These projects could receive funding if it becomes available in their year of construction.

This memorandum announces funding being made available for FY 2024 for the AMATS Connecting Communities Planning Grant Program. Attached is the Notice of Funding Available (NOFA) which details which types of projects are eligible for funding, as well as the timeline for the application process. Applications will be due February 9, 2024.

This will be the seventh round of Connecting Communities Planning Grants since the program's inception in 2010. AMATS plans to award two \$40,000 grants at the Policy Committee meeting on March 28, 2024.

### **Notice of Funding Available**

### **Connecting Communities Planning Grant**

The Akron Metropolitan Area Transportation Study developed the Connecting Communities Initiative to encourage the integration of land use and transportation. The purpose of the Connecting Communities Planning Grant Program is to fund transportation plans that are consistent with the Connecting Communities Initiative to promote livable communities through transportation planning. The Planning Grant Program has been created to provide communities with funding to develop transportation plans that will lead to projects eligible for AMATS funds.

### Connecting Communities principles:

- Increase alternative transportation options to connect people and places
- Promote Complete Street principles to create vibrant and safe places for all users
- Leverage transportation projects to develop places which support alternative transportation and complete streets through land use and design

To be eligible for a Connecting Communities Planning Grant, a project must:

- Be intended for transportation planning
- Be site specific
- Result in transportation and land use improvements that are consistent with *Connecting Communities A Guide to Integrating Land Use and Transportation*

### Ineligible activities include:

- Preliminary Engineering
- Final Design
- Preparation of environmental documentation
- Right-of-way acquisition
- Preparation of bid documents
- Construction

AMATS has made \$80,000 available for two \$40,000 planning grants to be awarded through the Connecting Communities Planning Grant Program. Projects may be a joint venture between sponsors, but each project is eligible for a maximum of one grant. Additionally, applications for no more than 2 projects may be submitted per community. A selection committee, The Connecting Communities Task Force, will be charged with reviewing sponsors' applications and making recommendations to the Policy Committee.

Local commitment, in the form of specific legislation, is required of sponsors and co-sponsors seeking planning grant funds. This ensures that Councils and Boards recognize that the project is being submitted for federal funding. Legislation must include the following: project name, description and cost. All projects are required to include legislation. Failure to submit legislation by the established due date may result in cancellation of project application.

### Important Dates:

**January 3, 2024** – Applications will be made available on the AMATS website.

**February 9, 2024** – Deadline to submit applications by 4:30 pm.

March 28, 2024 – Approval of grants takes place at the Policy Committee Meeting.

The following changes have been requested to the FY 2024-2027 Transportation Improvement Program:

### Combine Projects

The construction phase of the following two projects in Streetsboro are being combined into one project for more efficient project management. The combined project will use PID 105213. Construction is scheduled in FY 2026.

- 1. **POR-SR 14/43 1.74/15.59 (PID 105213)** Is a project that includes resurfacing and reconstruction of the SR 14/43 intersection in Streetsboro. Construction is scheduled for FY 2026.
- 2. **POR-SR 303/SR 14/Ranch Rd (PID 117173)** Is a project to add a new signal and removal of the WB slip ramp at the intersection of SR 14/303/Ranch Rd in Streetsboro. Construction is scheduled for FY 2026.

### Revise funding

3. **SUM-IR 76 6.72 (Kenmore Leg) (PID 100713)** – Is a project that includes improvements to increase capacity and improve safety including structural rehabilitation and noise walls. Preliminary engineering funds have been added to FY 2025.

### **STAFF COMMENTS**

As with all TIP amendments, considerations with respect to public participation, financial capability, air quality, environmental justice and Plan consistency are important. Sufficient funding is forecasted from federal and state sources for this amendment. The projects listed meet all amendment requirements mentioned above. Therefore, this amendment does not cause any negative impact.

### **STAFF RECOMMENDATION**

Attached to this memo is Resolution Number 2023-13. This Resolution approves the amendment to the FY 2024-2027 TIP. The Staff recommends approval.

- 3. **SUM-IR 76 6.72 (Kenmore Leg) (PID 100713)** Is a project that includes improvements to increase capacity and improve safety including structural rehabilitation and noise walls. Preliminary engineering funds have been added to FY 2025.

### **Executive Summary**

This memorandum discusses a TIP amendment to add recently awarded funding to the program of projects for both METRO RTA and PARTA.

The Ohio Department of Transportation (ODOT) has awarded METRO RTA and PARTA funding through its Ohio Transit Partnership Program (OTP2). This competitive grant program was established to provide additional capital funding to Ohio's public transit operators for projects emphasizing system preservation. In September, METRO and PARTA were awarded funds through this program for inclusion in FY 2024 of the AMATS Transportation Improvement Program (TIP). METRO received \$1,440,313 in federal funds. And PARTA received \$1,158,331 in federal funds. The source of the OTP2 awards is state-attributable Carbon Reduction Program (CRP) federal funds, as well as state of Ohio General Revenue Funds (GRF).

In addition, METRO received \$37,808,113 in competitive federal funds from the Federal Transit Administration (FTA) Low or No Emission Vehicle Program (FTA Section 5339c).

Consequently, METRO and PARTA are requesting that these additional funds be added to the TIP to include the recently awarded federal and state projects.

METRO RTA is requesting the following changes to the TIP:

# - Add Funds to an Existing Facility Construction Project (PID 104366)

METRO RTA requests the addition of \$37,808,113 in FTA Section 5339c discretionary funds awarded through the Low or No Emission Vehicle Program, for the construction of a new maintenance and operations facility. These recently awarded funds will replace METRO's FTA Section 5307 and 5339 allocations. The local share contribution is \$904,767. The total cost of the multi-year construction project is \$39,649,888. The

project spans FYs 2024-2026. METRO was also awarded additional funds in FY 2024 for the design of this facility. ODOT's OTP2 award for design is comprised of \$221,261 in CRP funds and \$121,300 in state General Revenue (GRF) funds.

# - Add Funding for the Acquisition of Bus Shelters (PID 104365)

This existing project entails the acquisition of bus shelters for use throughout METRO's service area. METRO is requesting to add \$173,192 in state-attributable CRP funds for this project. The local amount will be \$200,000. The total cost is \$373,192, remaining scheduled in FY 2024.

# - Add a Project for the Acquisition of Portable Vehicle Lifts (PID 120698)

METRO RTA requests the addition of \$134,400 in state-attributable CRP funds awarded recently by ODOT through their OTP2 Program, so that METRO may purchase portable lift sets. The project will be scheduled in FY 2024. The local share contribution is \$33,600, to match the awarded amount. The total project cost is \$168,000.

### - Add a Project for the Rehabilitation of Gas Tank (PID 120698)

METRO RTA requests the addition of \$299,460 in state-attributable CRP funds awarded recently by ODOT through their OTP2 Program, so that METRO may rehabilitate an underground unleaded gas tank. The project will be scheduled in FY 2024. The local share contribution is \$74,865, to match the awarded amount. The total project cost is \$374,325.

### - Add a Project for the Acquisition of Communications Equipment (PID 120698)

METRO RTA requests the addition of \$180,000 in state-attributable CRP funds awarded recently by ODOT through their OTP2 Program, so that METRO may purchase printers and upgrade their customer service phone system. The project will be scheduled in FY 2024. The local share contribution is \$45,000, to match the awarded amount. The total project cost is \$225,000.

### - Add a Project for the Purchase of Signage Equipment (PID 120698)

METRO RTA requests the addition of \$432,000 in state-attributable CRP funds awarded recently by ODOT through their OTP2 Program, so that METRO may purchase new wayfinding signs at their downtown Akron transit center. The project will be scheduled in FY 2024. The local share contribution is \$108,000, to match the awarded amount. The total project cost is \$540,000.

PARTA is requesting the following changes to the TIP:

### - Add a Bus Purchase Project (PID 120676)

PARTA requests the addition of \$319,930 in state-attributable CRP funds awarded through the OTP2 Program, for the partial acquisition of three large Compressed Natural

Gas (CNG) buses. The project is funded at 100 percent federal, scheduled in FY 2024, to assist with vehicle price increases due to the COVID-19 pandemic.

### - Add a Bus Purchase Project (PID 120676)

This request adds \$114,044 awarded through ODOT's OTP2 Program, for the partial purchase of two large CNG buses. The \$114,044 is comprised of \$105,938 in state general revenue (GRF) funds and \$8,106 in CRP federal funds. The total project cost is \$114,044, scheduled in FY 2024, to assist with vehicle price increases due to the COVID-19 pandemic.

# - Add an Automatic Passenger Counters Project (PID 120676)

PARTA has been awarded \$144,000 in state-attributable CRP funds awarded through the OTP2 Program, for the acquisition of automatic passenger counters. The local share contribution will be \$36,000. The total project cost is \$180,000 (80 percent federal), scheduled in FY 2024.

### - Add a Facility Paving Project (PID 120676)

PARTA requests the addition of \$96,000 in CRP funds (federal) awarded through the OTP2 Program, in support of a facilities rehabilitation paving project. The local share contribution is \$24,000. The total project cost is \$120,000 (80 percent federal), scheduled in FY 2024.

# - Add a Utility Support Vehicle Project (PID 120676)

PARTA requests the addition of \$30,400 in state-attributable CRP funds awarded through the OTP2 Program, for the acquisition of a vehicle for property maintenance. The local share contribution is \$7,600. The total project cost is \$38,000 (80 percent federal), scheduled in FY 2024.

### - Add a Maintenance Equipment Project (PID 120676)

This request adds \$157,000 in state-attributable CRP funds awarded through the OTP2 Program, for the acquisition of an emergency back-up generator and vehicle lift. The local share contribution is \$39,400. The total project cost is \$197,000 (80 percent federal), scheduled in FY 2024.

### - Revise Funding for Preventive Maintenance (PID 111802)

This existing PARTA project will reduce the total project cost from \$2,500,000 to \$1,375,000, due to revisions in a roof repair job. PARTA's federal share of funding will be reduced from \$2,000,000 to \$1,100,000 (80 percent federal), remaining scheduled in FY 2024.

### **STAFF COMMENTS**

As with all TIP amendments, considerations with respect to consistency with the Regional Transportation Plan, financial capability, air quality conformity, public involvement, and environmental justice are important.

### **Regional Transportation Plan**

The projects proposed in this amendment are consistent with *Transportation Outlook*, the area's Regional Transportation Plan.

### **Financial Capability**

With respect to financial capability, there are sufficient funds available for this amendment.

### **Air Quality**

The project can be viewed as either exempt from air quality or has been analyzed as part of the air quality networks and has resulted in a finding of compliance with the Clean Air Act. Therefore, this amendment will not affect adversely the air quality conformity approval of *Transportation Outlook* or the TIP.

#### **Public Involvement**

The Staff is recommending that the Policy Committee consider this action as not regionally significant. As a result, the modified procedures in the AMATS *Public Participation Plan* are appropriate.

### **Environmental Justice**

Executive Order 12898: Federal Actions to Address Environmental Justice in Minority Populations and Low Income Populations states that, "each federal agency shall make achieving environmental justice part of its mission by identifying and addressing as appropriate, disproportionately high and adverse human health or environmental effects of its programs policies and activities on minority and low-income populations." This requirement also applies to recipients of federal funds, such as METRO RTA and PARTA.

The project that will result from this TIP amendment does not appear to impose disproportionately high and adverse human health or environmental effects on minorities and/or low-income people who reside in the METRO RTA or PARTA service areas.

### STAFF RECOMMENDATION

Attached to this memo is Resolution 2023-14. This resolution approves the requested changes to FY 2024 of the AMATS Transportation Improvement Program as described above. The Staff recommends approval.

### **Executive Summary**

This memorandum discusses the latest biennial round of funding for the statewide CMAQ program.

The Congestion Mitigation and Air Quality (CMAQ) improvement program provides a flexible funding source for transportation projects to help meet the requirements of the Clean Air Act. Funding is available for air quality analysis areas such as the Akron metropolitan area. The CMAQ program supports two important goals: improving air quality and relieving congestion. The CMAQ program provides funding for a broad array of projects to accomplish these goals.

The Ohio Association of Regional Councils (OARC) Executive Directors established the Ohio Statewide Urban CMAQ Committee (OSUCC) to develop the process for managing the program. AMATS, along with the other seven large MPOs in Ohio, participates in this committee.

Following a statewide call for applications, the AMATS region received fifteen (15) applications from across the AMATS planning area totaling approximately \$57.5 million. Using the scoring criteria set up by the OSUCC, projects were scored and ranked. The table on the following page shows the four (4) projects recommended to receive funding through this CMAQ funding round.

#### STAFF RECOMMENDATION

As part of the development of the next TIP, these projects, if approved, will undergo public involvement and be analyzed for financial constraint, environmental justice, air quality and consistency with the Regional Transportation Plan. Attached to this memo is Resolution 2023-16. This resolution approves the CMAQ program funds awarded to the area. The Staff recommends approval.

This memorandum discusses an AMATS amendment to its FY 2024-2027 Transportation Improvement Program (TIP) conformity document to reflect a revision in funding to two capacity projects. The project scope and milestones remain unchanged. The projects have been analyzed for emissions in the current FY 2024-2027 TIP as well as the Regional Transportation Plan and are identified as follows:

- SUM-S Arlington Rd (PID 116917)
- SUM-IR 76 6.72 Kenmore Leg (PID 100713)

Because conformity is determined on a nonattainment area, rather than a sub area basis, the new regional air quality conformity determination will affect the Cleveland-Akron, Ohio Metropolitan Planning Organizations (MPOs).

In accordance with federal Transportation Conformity Regulations, 40 CFR Parts 51 and 93, the planning process has determined the revised projects add capacity and requires a conformity determination. Each of the area's planning partners have concurred through interagency consultation with conformity for the area based on these updates. The analysis for each standard includes partners from an eight-county area:

The Erie Regional Planning Commission (ERPC) serves all of Erie County and the Lorain County portion of the City of Vermilion, which is included in the Cleveland-Akron-Lorain air quality area. The Northeast Ohio Areawide Coordinating Agency (NOACA) serves Cuyahoga, Geauga, Lake, Lorain, and Medina counties. The Akron Metropolitan Area Transportation Study (AMATS) serves Portage and Summit counties. The Ohio Department of Transportation (ODOT) serves Ashtabula County for air quality conformity since Ashtabula is not part of an MPO.

AMATS has prepared the necessary analysis to demonstrate that the amendment of these documents will not interfere with the Cleveland-Akron area's air quality conformity status. The

summary of the conformity analysis is included in **Tables 1-4**.

Both USEPA and the Federal Highway Administration (FHWA) must then review and approve the conformity findings before they become effective. The emissions totals of the amended air quality conformity analysis demonstrate transportation conformity for the two projects noted as part of the Cleveland-Akron air quality nonattainment area.

### **Recommendations**

Resolution 2023-16 affirms the results of the attached analysis demonstrating transportation conformity for the S Arlington Road and IR 76 Kenmore Leg projects in Summit County as part of the Cleveland-Akron air quality nonattainment area. The Staff recommends approval.

WHEREAS, Portage and Summit Counties are included in the USEPA Cleveland-Akron-Lorain 8-Hour Ozone and PM2.5 Nonattainment Area designations; and

WHEREAS, the Metropolitan Planning Organizations (MPOs) and the Ohio Department of Transportation (ODOT) must reestablish conformity for the 2008 and 2015 8-Hour ozone standards and the 2006 and 2012 fine particulate matter (PM2.5) standards as a result of the adoption of FY 2024-2027 Transportation Improvement Programs (TIPs) and long range transportation plan amendments; and

WHEREAS, conformity is determined on a nonattainment area rather than a sub-area basis and each of the area's planning partners must approve a new conformity finding for the area based on these updates; and

WHEREAS, pursuant to US EPA regulations 40 CFR Part 93, Regional Transportation Plans and TIPs in non-attainment areas are required to demonstrate transportation conformity with the State Implementation Plan; and

WHEREAS, the attached air quality conformity analyses compares the projected transportation motor vehicle emissions against the budgets identified in the State Implementation Plan (SIP) for each standard for the pertinent portions of the counties of Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage and Summit; and

**WHEREAS**, the air quality analysis reflects an AMATS FY 2024-2027 TIP amendment for a revision in funding to the SUM-S Arlington Road (PID 116917) and SUM-IR 76 6.72 Kenmore Leg (PID 100713) projects; and

WHEREAS, the conformity analyses demonstrate that the Northeast Ohio Areawide Coordinating Agency (NOACA), the Akron Metropolitan Area Transportation Study (AMATS), and the Erie Regional Planning Commission (ERPC) TIPs and Long Range Transportation Plans in the eight county Cleveland-Akron-Lorain air quality nonattainment area are in conformity with USEPA air quality standards; and

WHEREAS, the necessary coordination between the Cleveland-Akron-Lorain Air Quality area partners: NOACA for Cuyahoga, Geauga, Lake, Lorain, and Medina Counties; AMATS for Portage and Summit Counties; ERPC for the Lorain County portion of the City of Vermilion; and ODOT for Ashtabula County, has occurred to establish conformity under the eight-hour ozone and fine particulate matter standards.

### NOW THEREFORE BE IT RESOLVED:

- 1. That this Committee affirms its approval of the attached air quality conformity analysis for the eight county Cleveland-Akron-Lorain air quality maintenance area for the 2008 8-hour Ozone standard, and marginal nonattainment area for the 2015 8-hour Ozone standard.
- 2. That this Committee affirms its approval of the attached air quality conformity analysis for the eight county Cleveland-Akron-Lorain air quality maintenance area for 2006 and 2012 PM<sub>2.5</sub> standards.
- 3. That this Committee affirms the consistency between the Portage and Summit Counties portion of the AMATS Regional Long Range Transportation Plan, Transportation Improvement Program (TIP), and the State Implementation Plan (SIP).
- 4. That this Committee affirms interagency consultation has occurred between its non-attainment partners (NOACA, AMATS, ERPC, and ODOT) to ensure conformity analyses.
- 5. That this Committee authorizes the Staff to provide copies of this Resolution to the appropriate agencies as evidence of action by the Metropolitan Transportation Policy Committee.
