

#### I. <u>Call to Order</u>

**A.** Chairwoman Connie Krauss called the meeting to order. The attending members constituted a quorum.

#### **B.** Audience Participation

None.

#### II. <u>Minutes – Motion Required</u>

#### A. Approval of Minutes

Members were asked to approve the minutes of the September 25, 2013 meeting.

<u>Motion</u>

*David Kline* made a motion to approve the minutes and it was seconded by *Frank Hairston*. *The motion was approved by a voice vote.* 

#### III. <u>Staff Reports</u>

#### A. Financial Progress Report

Jason Segedy presented Attachment 3A.

**Motion** 

**Bill Goncy** made a motion to approve the Financial Progress Report and it was seconded by **Al Bollas**. <u>The motion was approved by a voice vote.</u>

#### **B.** Technical Progress Report

**Curtis Baker** said that the AMATS Policy Committee and TAC would have their meetings at Quaker Square facilities in 2014.

**Mr. Baker** summarized various funding proposals being considered by Congress as part of the next federal transportation spending bill. **Mr. Baker** noted that the current law, MAP-21, will expire in October 2014.

**Mr. Baker** said that the AMATS Connecting Communities Planning Grant Program selected Bath and Copley townships and the city of Barberton as its FY 2013 recipients of two \$50,000 program grants.

**Mr. Baker** said that the Staff has compiled a Bicycle Related Traffic Crashes 2010-2012 Technical Memorandum, which would be presented by Dave Pulay during the meeting.

#### C. AMATS Federal Funds Report

**Victor Botosan** presented Attachment 3C and tables concerning Funding Program and Balances dated December 10, 2013.

**Mr. Botosan** said that ODOT has officially adopted the *Ohio Statewide Urban CMAQ Program Policy*. **Mr. Botosan** explained how this policy will impact AMATS and its CMAQ application process in 2014.

**Mr. Botosan** said that the TAC TIP Subcommittee will be scoring and ranking the project applications that the agency received for STP, TAP and Resurfacing funding in accordance with *AMATS Funding Policy Guidelines*. Project recommendations should be presented during the January 2014 TAC and Policy Committee meetings.

#### IV. Old Business

**ODOT District 4 Deputy Director Anthony Urankar** said that ODOT's *Resource Guide Winter 2013-2014* was available and provided copies to the committee.

Mr. Urankar said that page 9 of the guide describes the new Turnpike Mitigation Program. This program will allocate approximately \$5 million annually to fund projects within a one-mile, north-south area of the Ohio Turnpike for communities that are impacted by traffic or turnpike operations. Mr. Urankar said that communities in the AMATS area that could benefit from the program include Streetsboro, Freedom Township, Shalersville, Windham, Boston Heights, Hudson, Richfield, Boston Township and Richfield Township. Mr. Urankar noted that the city of Streetsboro has applied to the program and he encouraged other eligible communities to contact the department if they are so interested.
Mr. Urankar said that information about the program is available on ODOT's web site and that the link and additional information would be relayed to AMATS. Mr. Urankar said that applications should be submitted to ODOT by Jan. 31, 2014 and funding decisions would be announced in spring 2014.

**Frank Hairston** asked Mr. Urankar for a clarification as to whether he was referring to Windham Township or the Village of Windham. **Mr. Urankar** said that he was referring to both.

#### V. <u>New Business</u>

#### A. AMATS: The State of Our Region's Transportation Infrastructure.

Nate Brugler presented Attachment 5A.

**Amy Mohr** asked if the dates that data was collected were included in the report. **Mr. Brugler** said yes and explained how dates were documented in the report's footnotes.

**Rich Enty** asked if the report addressed railroads and public transit facilities. **Mr. Brugler** said that, in its first attempt at compiling this type of report, AMATS considered the availability of data and began by judging federally classified highways, which are used by buses. **Mr. Brugler** said that the Staff could attempt to quantify the individual assets of transit agencies. **Mr. Brugler** explained that railroad bridges were omitted from the report as AMATS does not have a direct impact on their funding or maintenance.

**Mr. Enty** noted that the FTA is requiring transit systems to be more attentive to asset maintenance. **Mr. Enty** said that METRO could provide AMATS with the reports that it prepares for the FTA regarding the maintenance and status of its facilities. **Mr. Segedy** said that the Staff could work with METRO and PARTA to assess the area's public transit infrastructure as a separate report or an addendum to the infrastructure report.

Mayor Bollas asked if the FTA inspects rail bridges owned by METRO. Mr. Enty said that the FRA conducts inspections of bridges and tracks owned by METRO. Mayor Bollas asked how rail bridge inspections are conducted. Mr. Enty explained that METRO must bring an FRA-certified inspector several times a year to inspect its properties. Mayor Bollas asked if there was an increase in area rail traffic. Mr. Enty said that METRO's rail traffic levels are stable and that METRO officials have been talking with more companies that are interested in transporting rail products. Chairwoman Krauss noted that Summit County officials have noticed an increase in the number of companies that are interested in sites with rail access.

**Mayor Bollas** observed that railroads, such as CSX, do not seem to have a presence on planning organizations. **Mr. Segedy** noted that AMATS does have a rail representative from the Wheeling & Lake Erie Railway on its TAC.

#### B. Bicycle Related Crashes 2010-2012.

Dave Pulay presented Attachment 5B.

**Mayor Knack** suggested that AMATS send the report to the Ohio Department of Education for possible use in driver training courses. **Mr. Pulay** said that the agency could do so. **Mr. Pulay** suggested that the report could be a resource for grade school physical education classes.

**Christopher Mallin** praised the compilation of the report. **Mr. Mallin** asked if copies of the Bike Crashes 2010-2012 map to which Mr. Pulay referred were available. **Mr. Pulay** said that the map would be available online and that the Staff would distribute the map to the members via email.

Mayor Currin noted that there is a significant lack of citations issued to motor vehicle operators in bike-vehicle accidents even in the most severe of such occurrences. The mayor asked if the report addressed why this relationship exists. Mr. Pulay said that the Staff was not aware of the lack of citations. Mr. Segedy said that the agency would research such occurrences. Mr. Segedy noted that bike advocates feel a significant bias exists against them versus motor vehicle operators. Mr. Segedy asked Mayor Currin for his information regarding citations. The mayor said that he would try to send it to the Staff. Mayor Currin noted that there is also a significant lack of courtesy shown to cyclists by motor vehicle operators even where dedicated bike lanes exist.

**Mr. Mallin** noted that the ODPS reports should indicate where citations have been issued. **Mr. Pulay** said that he would research the issuance of citations.

#### VI. <u>Resolutions – Approval Requested</u>

A. Resolution 2013-17 – Conformity Determination and Concurrence with the Revised Air Quality Conformity Analyses for the Cleveland-Akron Air Quality Area Necessitated by the Amendment to Transportation Outlook 2035 and the TIP FY 2014-2017.

Phyllis Jividen presented Attachment 6A.

<u>Motion</u>

*Glenn Broska* made a motion to approve Resolution 2013-17 and it was seconded by *Frank Hairston*. *The motion was approved by a voice vote*.

## B. Resolution 2013-18 – Approving Amendment #1 to Transportation Outlook 2035 to add I-271 widening.

Krista Beniston presented Attachment 6B.

**Mr. Mallin** asked if the amendment represented an additional \$57 million for *Transportation Outlook 2035*. **Ms. Beniston** said that the total is approximately \$61 million and comes from the issuance of Ohio Turnpike bonds. **Ms. Beniston** explained that the addition of the project does not impact the fiscal constraint of *Transportation Outlook 2035*, but it will increase the amount of funding recommended in the regional transportation plan. **Mr. Segedy** said that the Staff didn't forecast turnpike bond revenue when developing the plan, but the state has since authorized the availability of these funds. **Mr. Mallin** asked whether the funding listed for the I-271 project was coming from another project. **Mr. Segedy** said no and explained that it was from a separate new funding source.

#### **Motion**

*Mohamed Darwish* made a motion to approve Resolution 2013-18 and it was seconded by *Frank Hairston*. <u>The motion was approved by a voice vote.</u>

C. Resolution 2013-19 – Approving Amendment #5 to the Transportation Improvement Program FY 2014-2017 to add I-271 widening.

Mr. Botosan presented Attachment 6C.

<u>Motion</u>

*William Currin* made a motion to approve Resolution 2013-19 and it was seconded by **David Kline**. <u>The motion was approved by a voice vote</u>.

D. Resolution 2013-20 – Approving Amendment #6 to the Transportation Improvement Program FY 2014-2017 to Add Aurora Safe Routes to School (SRTS) Plan, Barberton SRTS, Ellsworth Hill SRTS, and Rittman SRTS, Revise the schedule of Hiram Village Sidewalks and Howe Avenue, and Cancel SR 619 (Wooster Road).

Mr. Botosan presented Attachment 6D.

<u>Motion</u> *Rich Enty* made a motion to approve Resolution 2013-20 and it was seconded by *Gene Roberts*. <u>The motion was approved by a voice vote.</u>

E. Resolution 2013-21 – Approving Amendment #7 to the Transportation Improvement Program FY 2014-2017 - To Add and Revise Funds in FY 2014 for PARTA Capital Projects.

Jeff Gardner presented Attachment 6E.

<u>Motion</u>

*Rick Bissler* made a motion to approve Resolution 2013-21 and it was seconded by *Bill Goncy*. *The motion was approved by a voice vote*.

#### VII. Other Business

#### A. Report of 2014 Nominating Committee

**Chairwoman Krauss** presented the report of the 2014 Nominating Committee consisting of herself, Mayor Beshara and Mayor Bica. The committee nominated Tallmadge Mayor David Kline to serve as chairman and Kent Service Director Gene Roberts as vice chairman in 2014.

#### <u>Motion</u>

*Frank Hairston* made a motion to close nominations and accept the slate of officers presented by the 2014 Nominating Committee and it was seconded by *Mohamed Darwish*. <u>The motion was approved by a voice vote.</u>

**Chairwoman Krauss** thanked Mayor Kline and Mr. Roberts for agreeing to serve as chairman and vice chairman in 2014. **Chairwoman Krauss** also praised the Staff for the assistance that she received during her term as chairwoman.

#### B. 2014 AMATS Meeting Calendar

Mr. Segedy presented Attachment 7B.

#### <u>Motion</u>

**David Kline** made a motion to approve the 2014 AMATS Meeting Calendar and it was seconded by **Glenn Broska**. <u>The motion was approved by a voice vote.</u>

#### C. Presentation of Award to Chairwoman Krauss

**Mr. Segedy** presented **Chairwoman Krauss** with a plaque from the Policy Committee in appreciation of her service as committee chairwoman during 2013.

#### D. Northeast Ohio Sustainable Communities Consortium Findings - Discussion

Mr. Segedy presented Attachment 7C.

Mr. Segedy introduced Hunter Morrison, the director of the NEOSCC.

**Mr. Morrison** thanked Chairwoman Krauss, Mr. Segedy, and AMATS for their commitment to the NEOSCC. **Mr. Morrison** presented the findings of the NEOSCC and referred to handouts concerning the *Vibrant NEO 2040* Vision, Framework and Action Products.

Mayor Currin asked if the NEOSCC Board of Directors meeting on Dec. 17 was to vote on the *Vibrant NEO 2040* Vision, Products and Framework documents. Mr. Morrison said that the board met to vote on authorizing the NEOSCC Staff to release the documents to NEOSCC member organizations for review, consideration and potential vote of approval. Mr. Morrison said that the documents are now available to members for perusal. Mayor Currin asked if the board vote was unanimous to do so. Mr. Morrison said yes.

**Mayor Currin** asked about a proposed structure for the NEOSCC and when that might be announced. **Mr. Morrison** said that the consortium was originally established as a non-profit organization. **Mr. Morrison** explained that the consortium established a Futures Committee six months ago to define the role and mission of the NEOSCC when its current federal HUD grant expires. The Futures Committee identified three mission areas for the NEOSCC: advising, assembling/convening and advocating. The board elected to accept the Futures Committee's direction and assigned the Executive Committee the responsibility of how to do so.

Mr. Morrison referred to the NEOSCC's Action Products.

#### I. <u>Call to Order</u>

**A. Chairman Fred Guerra** called the meeting to order in the conference room of the Stow Safety Building. The attending members constituted a quorum.

#### II. <u>Minutes – Motion Required</u>

#### A. Approval of Minutes

Members were asked to approve the minutes of the September 19, 2013 meeting.

#### **Motion**

*David Gasper* made a motion to approve the minutes and it was seconded by *John Kovacich*. *The motion was approved by a voice vote.* 

#### III. Staff Reports

#### A. Financial Progress Report

Jason Segedy presented Attachment 3A.

#### **Motion**

**David White** made a motion to approve the Financial Progress Report and it was seconded by **Bryan Smith**. <u>The motion was approved by a voice vote.</u>

#### **B.** Technical Progress Report

**Curtis Baker** said that the AMATS Connecting Communities Planning Grant Program selected Bath and Copley townships and the city of Barberton as its FY 2013 recipients of two \$50,000 program grants. City Architecture was selected to conduct Barberton's *North-South Community Connection Plan* and Environmental Design Group (EDG) was selected to do the *Montrose: North/South East/West* study on behalf of the townships.

**Mr. Baker** said that the Staff has compiled a Bicycle Related Traffic Crashes 2010-2012 Technical Memorandum, which would be presented by Dave Pulay

during the meeting. **Mr. Baker** said that the Staff is developing a Pedestrian Crash Report.

**Mr. Baker** summarized various funding proposals being considered by Congress as part of the next federal transportation spending bill. **Mr. Baker** noted that the current law, MAP-21, will expire in October 2014.

**Mr. Baker** said that AMATS Planning Coordinator Krista Beniston recently distributed copies of a draft Bike Lane Map for review. **Mr. Baker** said that the Staff has received many comments regarding this item and will update the map accordingly. The map should be ready for presentation to the TAC in January 2014.

#### C. AMATS Federal Funds Report

**Victor Botosan** presented Attachment 3C and tables concerning Funding Program and Balances dated December 10, 2013.

**Mr. Botosan** said that ODOT has officially adopted the *Ohio Statewide Urban CMAQ Program Policy*. **Mr. Botosan** explained how this policy will impact AMATS and its CMAQ application process in 2014.

**Mr. Botosan** said that AMATS received 38 STP funding applications totaling \$98 million; 26 TAP funding applications totaling \$11 million; and 68 Resurfacing funding applications totaling \$32 million. The agency received 132 applications seeking \$141 million in project funding. The TAC TIP Subcommittee will have two meetings to score and rank project applications. Project funding recommendations should be presented during the January 2014 TAC and Policy Committee meetings.

**Bryan Smith** asked if copies of the new CMAQ policies are available. **Mr. Segedy** said that AMATS would provide the members with copies once they become available.

#### IV. Old Business

#### V. <u>New Business</u>

#### A. AMATS: The State of Our Region's Transportation Infrastructure.

Nate Brugler presented Attachment 5A.

#### B. Bicycle Related Crashes 2010-2012

**Dave Pulay** presented Attachment 5B. **David Gasper** asked how many crashes occurred at marked bike lanes and sharrows and if such information was available in crash reports. **Mr. Pulay** said that there were few crash reports that indicated such information. **Mr. Segedy** asked if Seth Bush, the AMATS GIS coordinator, overlaid bike lane information over crash locations using GIS in developing the report's map. **Mr. Pulay** said yes. **Mr. Segedy** indicated that the Staff could relay that information for the city of Akron to Mr. Gasper. **Mr. Gasper** said that he would be interested in receiving the map.

**David White** asked if documentation was available as to the increase in the number of marked bike lanes and signage. **Mr. Segedy** said yes and noted that it would be included in the Bike Lane Map that Mr. Baker mentioned during the Technical Progress Report.

**Joseph Hadley** asked how AMATS would use the information contained in the report. **Mr. Pulay** said that it would be an educational tool for drivers, cyclists and children.

**Mr. Baker** noted that there is a discernible correlation between crash locations and the need for bike projects, which could be a consideration in the awarding of funding for complete street-type projects.

There was discussion regarding sidewalk and cycling safety issues.

**Tony Demasi** asked why the map identifying crash locations to which Mr. Pulay referred during his presentation was not included in the report. **Mr. Pulay** said that the map would be available online and would be emailed to the members.

#### VI. <u>Resolutions</u>

Phyllis Jividen presented Attachment 6A.

#### <u>Motion</u>

**David White** made a motion to approve Resolution 2013-17 and it was seconded by **David Gasper**. <u>The motion was approved by a voice vote</u>.

## B. Resolution 2013-18 – Approving Amendment #1 to Transportation Outlook 2035 to add I-271 widening.

Mr. Baker presented Attachment 6B.

#### <u>Motion</u>

**David White** made a motion to approve Resolution 2013-18 and it was seconded by **Elwood Palmer**. <u>The motion was approved by a voice vote.</u>

#### C. Resolution 2013-19 – Approving Amendment #5 to the Transportation Improvement Program FY 2014-2017 to add I-271 widening.

Mr. Botosan presented Attachment 6C.

**Mr. Smith** asked how a nearly \$60 million project to add capacity could be reconciled when the region already has \$140 million in project requests and only \$20 million available in funding. **Mr. Segedy** explained that the project is being financed with Ohio Turnpike Commission bonds.

#### <u>Motion</u>

**Tony Demasi** made a motion to approve Resolution 2013-19 and it was seconded by **Bryan Smith**. <u>The motion was approved by a voice vote.</u>

D. Resolution 2013-20 – Approving Amendment #6 to the Transportation Improvement Program FY 2014-2017 to Add Aurora Safe Routes to School (SRTS) Plan, Barberton SRTS, Ellsworth Hill SRTS, and Rittman SRTS, Revise the schedule of Hiram Village Sidewalks and Howe Avenue, and Cancel SR 619 (Wooster Road).

Mr. Botosan presented Attachment 6D.

#### <u>Motion</u>

**Bryan Smith** made a motion to approve Resolution 2013-20 and it was seconded by **David White**. <u>The motion was approved by a voice vote</u>.

#### E. Resolution 2013-21 – Approving Amendment #7 to the Transportation Improvement Program FY 2014-2017 - To Add and Revise Funds in FY 2014 for PARTA Capital Projects.

Jeff Gardner presented Attachment 6E.

**Wayne Wiethe** asked about the percentage of CNG buses that PARTA has in its fleet. **Mr. Smith** said that PARTA has no CNG buses as it has no facilities to support them. **Mr. Smith** said that PARTA must construct such facilities before it can purchase CNG vehicles.

#### <u>Motion</u>

**Bryan Smith** made a motion to approve Resolution 2013-21 and it was seconded by **David Gasper**. <u>The motion was approved by a voice vote</u>.

#### VII. Other Business

#### A. Report of 2014 Nominating Committee

**Chairman Guerra** presented the report of the 2014 Nominating Committee consisting of himself, Mr. Hadley and Mr. Gasper. **Mr. Guerra** praised AMATS Public Information Coordinator Kerry Prater for his assistance throughout the nominating process. The committee nominated New Franklin Service Director

Jeff Olson to serve as chairman and Portage Park District Executive Director Chris Craycroft as vice chairwoman in 2014. **Mr. Guerra** noted that Ms. Craycroft is the first female member to be elected to a chair or vice chair position of the TAC in the agency's history.

#### <u>Motion</u>

Wayne Wiethe made a motion to close nominations and accept the slate of officers presented by the 2014 Nominating Committee and it was seconded by Bryan Smith. The motion was approved by a voice vote.

#### B. 2014 AMATS Meeting Calendar

Mr. Segedy presented Attachment 7B.

**Mr. Segedy** said that the TAC and Policy Committee would be meeting at Quaker Square facilities in Akron during 2014. **Mr. White** asked if a map with the new meeting location and available parking could be prepared for the members. **Mr. Segedy** said yes.

#### **Motion**

*David White* made a motion to approve the 2014 AMATS Meeting Calendar and it was seconded by *John Trew*. <u>The motion was approved by a voice vote</u>.

#### C. Northeast Ohio Sustainable Communities Consortium Findings - Discussion

Mr. Segedy presented Attachment 7C.

Mr. Segedy introduced Hunter Morrison, the director of the NEOSCC.

**Mr. Morrison** thanked AMATS and NEFCO for their level of engagement with the consortium. **Mr. Morrison** presented the findings of the NEOSCC and referred to handouts concerning the *Vibrant NEO 2040* Vision, Framework and Action Products.

**Mr. Segedy** asked if additional information was available online. **Mr. Morrison** said that additional information is available on the *Vibrant NEO 2040* web page.

**Mr. Guerra** asked when Mr. Morrison could speak before the city councils and planning commissions. **Mr. Morrison** said that the consortium was planning on such presentations during January and February 2014, but could accommodate earlier requests.

**Mr. Pulay** noted that Mr. Morrison indicated in his presentation that much of the region's vacant housing problems were largely attributable to suburban migration. **Mr. Pulay** asked if the NEOSCC considered the region's number of bankruptcies and business failures as contributing factors. **Mr. Morrison** said that the consortium's scenario planning models were used by Cleveland State University and Youngstown State University and were based on the historical pattern that people tend to migrate from older to newer housing. Historically, newer housing

is located in the suburban areas. **Mr. Morrison** described some of the consequences of the bursting of the subprime mortgage lending "bubble" on the region's older housing markets.

**Ms. Craycroft** asked if schools were a factor in the area's population trends. **Mr. Morrison** said that school quality tends to proximate housing. There was discussion regarding the quality of school districts in housing and living choices.

#### D. Presentation of Award to Chairman Guerra

**Mr. Segedy** presented **Chairman Guerra** with a certificate of appreciation from the TAC in recognition of his service as committee chairman during 2013.

#### I. Call to Order

**Chairperson Ondecker** called the meeting to order. The attending members constituted a quorum.

**Chairperson Ondecker** asked for introductions of those present. Introductions were made.

#### II. Minutes

Members were asked to approve/disapprove the minutes of the September 19, 2013 meeting.

#### **Motion**

*David H. Mangold* made a motion to approve the minutes and it was seconded by *Michael Ondecker*. *The motion was approved by a voice vote.* 

#### III. Staff Reports

**Krista Beniston** presented the Technical Progress Report and referred to Attachment 3C – AMATS Federal Funds Report.

**Ms. Beniston** summarized recent developments concerning the AMATS Connecting Communities Planning Grant Program. The preliminary findings of AMATS' *Building a Better Montrose* survey are available at **amatsplanning.org** and the agency has selected Environmental Design Group (EDG) as the consultant to oversee Bath and Copley townships' *Montrose: North/South East/West* study. **Ms. Beniston** said that work on the townships' study and Barberton's *North-South Community Connection Plan* should commence in spring 2014.

Mr. Mangold praised the agency for addressing pedestrian issues in the Montrose area.

#### **IV. Staff Presentations**

**Nate Brugler** presented Attachment 5A – The State of Our Region's Transportation Infrastructure Report.

**Chairperson Ondecker** asked if funding sources were available for bridge repairs on an expedited basis if an important bridge is found to have an imminent problem. **Mr. Brugler** explained that AMATS' funding programs generally are not used solely for bridge projects, but are used in combination with other funding sources for projects which may include bridge work. **Mr. Brugler** said that the Ohio Department of Transportation (ODOT), counties and cities usually fund such projects and can expedite such projects.

**Mr. Brugler** noted that ODOT is making the repair of bridges a priority across the state through its \$120 million **Ohio Bridge Partnership Program**, which was announced in October. **Steve Rebillot** said that 18 structures within the ODOT District 4 area are eligible for the program. **Mr. Rebillot** said that the County Engineers Association of Ohio has a program that provides emergency funding for bridge repair projects.

**Chairperson Ondecker** summarized Attachment 6A-Resolution 2013-17, Attachment 6B-Resolution 2013-18, Attachment 6C-Resolution 2013-19, Attachment 6D-Resolution 2013-20 and Attachment 6E-Resolution 2013-21 on behalf of the committee members. The **chairperson** noted that the CIC must consider these items.

**Ms. Beniston** presented Attachment 6B-Resolution 2013-18 – Approving Amendment #1 to *Transportation Outlook 2035* to add I-271 widening and Attachment 6C-Resolution 2013-19 – Approving Amendment #5 to the Transportation Improvement Program FY 2014-2017 to add I-271 widening. **Mr. Mangold** questioned the need for the Interstate 271 project and said that it would not ease traffic problems between I-271 and Interstate 480. **Mr. Mangold** expressed concerns about the need for widening projects and urged the pursuit of alternative forms of transportation, such as commuter rail. **Ms. Beniston** noted that I-271 will be widened to six lanes north of the Cuyahoga-Summit County Line and – if the Summit County portion is not widened – a potential bottleneck and related issues may result in the area. **Jason Segedy** added that the project is being done in concert as part of a larger strategy. **Mr. Rebillot** said that ODOT District 12 has a project scheduled to sell in 2015 that will widen I-271 within Cuyahoga County.

There was discussion regarding traffic congestion and the Level of Service (LOS) in the I-271 project area and the overall need for the project.

**Mr. Maki** expressed support for the ODOT position of combining projects to improve I-271 given the area's traffic slowdowns.

#### V. Other Policy Committee Agenda Items

**Chairperson Ondecker** welcomed Hunter Morrison, the director of the Northeast Ohio Sustainable Communities Consortium (NEOSCC).

Mr. Segedy presented Attachment 7C.

Mr. Segedy introduced Mr. Morrison.

**Mr. Morrison** praised the work of AMATS as one of the founding organizations of the NEOSCC. **Mr. Morrison** presented the findings of the NEOSCC and referred to handouts concerning the *Vibrant NEO 2040* Vision, Framework and Action Products.

**Mr. Mangold** asked how the NEOSCC is funded. **Mr. Morrison** explained that the consortium is funded through two sources: a federal grant from the U.S. Department of Housing and Urban Development (HUD) and matching funds from The Fund for Our Economic Future. **Mr. Mangold** asked if the consortium would be sustainable beyond the federal grant. **Mr. Morrison** said that the NEOSCC's Executive Committee is researching the consortium's future post-federal planning grant. **Mr. Mangold** expressed support for the NEOSCC.

**Chairperson Ondecker** said that he could foresee a confrontation between NEOSCC supporters and those stakeholders who prefer the status quo.

**Chairperson Ondecker** invited Mr. Morrison to return to the CIC for a follow-up presentation once the consortium's upcoming public meetings conclude. **Mr. Morrison** said that he was willing to do so. **Chairperson Ondecker** thanked Mr. Morrison for his presentation.

#### <u>Motion</u>

*William J. Maki* made a motion that the CIC recommend approval of Attachment 6A – Resolution 2013-17, Attachment 6B-Resolution 2013-18, Attachment 6C-Resolution 2013-19, Attachment 6D-Resolution 2013-20 and Attachment 6E-Resolution 2013-21 to the Policy Committee and it was seconded by David Kish.

**Chairperson Ondecker** called for a vote on the motion. <u>*The motion was approved*</u> <u>*by a voice vote.*</u>

**Chairperson Ondecker** noted that Attachment 7B - 2014 AMATS Meeting Calendar was included in the meeting materials.

#### VI. Other Business

**Chairperson Ondecker** opened the floor to discussion regarding the election of CIC officers for 2014.

#### FY 2014 Ending Balance

If all of the programmed projects scheduled for implementation in FY 2014 were to be encumbered, the ending balance would be approximately \$12 million. This ending balance exceeds the allowable carry forward amount that ODOT has set for MPOs in Ohio. This large balance is due to a combination of factors that include delayed project schedules, low bid amounts and most significantly, the accumulation of funds for future year projects.

In order to avoid a potential lapse in funds, the Staff is working to trade funds with several MPOs in Ohio. Presently, AMATS should be able to trade a majority of the \$12 million balance to avoid any potential lapsing of funds. All funds that are traded with another MPO will be returned to AMATS by FY 2016 for programmed projects.

#### New Statewide CMAQ Funding Program for Ohio MPOs

Solicitation of new CMAQ projects at the individual MPO level will begin this coming spring. As in our normal rounds of funding, the TAC TIP Subcommittee and the Staff will oversee the process and recommend to the Policy Committee a list of prioritized projects to submit to the statewide CMAQ committee in the fall. The statewide CMAQ committee will issue final project funding approvals by the end of calendar year 2014. The newly approved projects will be programmed for implementation in FY 2018 and beyond.

#### New Project Funding Recommendations

The TAC TIP Subcommittee has met to develop project funding recommendations for the STP, TAP and Resurfacing programs. The Subcommittee's project recommendations will be presented at the January TAC and Policy committees for final approval.

**DATE:** January 15, 2014

A draft Transportation Planning Work Program and Budget is submitted annually to ODOT for review. The Work Program identifies the planning activities that will take place in the upcoming fiscal year and describes the funding sources that will be used to pay for them. Once ODOT completes its review of the Work Program, it is presented to the Policy Committee for final adoption in May.

The major source of funding for activities listed in the Work Program is United States Department of Transportation (USDOT) Consolidated Planning funding. Other sources of revenue include federal Congestion Mitigation/Air Quality (CMAQ) funds, as well as state and local funds.

It has been estimated that \$1,126,883 in federal Consolidated Planning Grant (CPG) funds will be available to AMATS for planning activities in FY 2015. These funds must be matched by state and local funds at a percentage rate of 80/10/10, yielding a total budget of \$1,408,604. Remaining funds from this fiscal year (FY 2014) will be carried over on July 1, and may be used through December 31, 2014.

The total local match for FY 2015 is calculated to be \$154,860, which includes local share funds to be used in matching federal CMAQ dollars as part of the Rideshare and Air Quality Programs.

Table 1 shows the draft local share calculation for each individual member of AMATS. Each member's contribution is based on the dues structure established by the Policy Committee in 2005. The dues structure is based on population. Local share amounts were modified following the release of the 2010 Census figures in February 2011.

As a result, the FY 2015 per capita assessment for each community has been set at \$0.183. METRO and PARTA will be assessed collectively \$25,000.

Table 2 shows the work elements and major planning tasks for FY 2015. Key activities include:

- Developing a new Transportation Improvement Program (FY 2016-2019)
- A Study of Existing Traffic Congestion
- A Road Diet Analysis
- Participating in the new Statewide CMAQ Discretionary Funds Program
- Directing the Rideshare and Air Quality Advocacy Programs
- Developing demographic and land use data for the next Regional Transportation Plan
- Integrating performance measures as part of the Plan and TIP processes consistent with MAP-21
- Finalizing the NEOSCC Vibrant NEO Sustainability Initiative

Table 3 summarizes all funds budgeted in the Work Program by source. Also included in Table 3 are planning activities performed by METRO and PARTA.

The Staff is requesting approval of the draft *FY 2015 Transportation Planning Work Program and Budget* and asks for permission to submit it to ODOT for review. The Staff will then meet with ODOT in April to discuss any comments. A final version of the Work Program will be submitted for Policy Committee approval in May.

### **DATE:** January 15, 2014

The AMATS Policy Committee administers the Surface Transportation (STP), Transportation Alternatives (TAP) and Resurfacing funding programs. These programs provide much needed funds for area highway, bike and pedestrian projects. As part of administering these funds, the Policy Committee has assigned the TAC TIP Subcommittee the responsibility to maintain a viable program and to make recommendations to the Policy committee as needed. Staff assistance is provided to the TAC TIP Subcommittee in performing these duties.

The TAC TIP Subcommittee met in December and again in January to review recently submitted project applications, apply approved evaluation criteria and develop a list of recommendations for STP, TAP and Resurfacing projects to be considered for funding and inclusion, where applicable, in the Transportation Improvement Program. One hundred and thirty-three applications were received from member sponsors totaling over \$114 million in requests for federal funds.

Project Funding Recommendations

#### **Surface Transportation Program**

The attached Table 1 summarizes all 39 projects that were submitted under the STP funding program. Twelve projects, totaling \$17.9 million, are being recommended for funding and are listed in bold type on the table. The project summaries include total project scores based on criteria contained in AMATS Funding Policy Guidelines.

### **Transportation Alternatives Program**

The attached Table 2 summarizes all 26 projects that were submitted under the TAP funding program. Eleven projects, totaling \$3.9 million, are being recommended for funding.

### **Resurfacing Program**

The attached Table 3 summarizes all 68 projects that were submitted under the Resurfacing program. Sixteen projects, totaling \$6.9 million, are being recommended for funding. The project summaries also include total project scores.

All of the projects recommended for funding are included on the attached map.

### Impact on Funding Program

The attached Funding Program and Balances table includes AMATS funded projects currently in the TIP and those being recommended for funding. As can be seen from the table, new recommended project funding totaling \$28.7 million consumes available balances into FY 2021.

The funding for projects that were reapplied for will be matched up with their current project schedule and newly applied for projects will be programmed in fiscal years beyond the TIP, except in the case of Resurfacing projects because they can be ready for construction within a year or two. The initial placement of these projects in the overall funding program is only for purposes of filling the program and will be subject to change after scope meetings are held and projects begin development.

In fiscal years where project expenditures exceed the available budget, trading funds with another MPO will be pursued. There may be instances where a trade is not possible or is not adequate to advance all programmed projects in a particular year. In this case, a project may be delayed to the next fiscal year.

### Staff Comments

As with all AMATS project decisions, considerations with respect to public involvement, financial capability, environmental justice, and air quality are important.

### **Public Involvement**

One of the eligibility requirements for funding projects with AMATS Suballocated funds is that the project be included in the Regional Transportation Plan. All of the projects recommended for funding are consistent with the Plan, which gives priority to preserving the existing transportation system, and have therefore gone through public involvement in accordance with AMATS Public Participation Plan.

Because of this past action, the Staff recommends that the Policy Committee consider this funding action as not regionally significant. As a result, the modified procedures in the Public Participation Plan are appropriate. These procedures include a notification in the Akron Beacon Journal that these resolutions will be presented for comment at a Citizens Involvement Committee meeting scheduled for January 23, 2014. Any comments on these projects will then be forwarded to the Policy Committee meeting on January 30.

### **Financial Capability**

In order to adequately fund these recommended projects with expected balances of the STP and TAP Programs, AMATS will need to trade funds with one or more MPOs and/or possibly move a number of projects beyond the FY 2017 timeframe.

### **Environmental Justice**

These projects have gone through an environmental scan as part of the development of the Regional Transportation Plan and do not to have any adverse environmental impacts on minorities and/or low-income people.

### Air Quality

Finally, these projects can be viewed as either exempt from air quality or have been analyzed as part of the air quality networks and are in compliance with the Clean Air Act.

### **STAFF RECOMMENDATIONS**

Attached to this memo are Resolution Numbers 2014-01, 2014-02 and 2014-03 approving projects to be funded under the STP, TAP and Resurfacing funding programs and included in the Transportation Improvement Program FY 2014-2017. The TAC TIP Subcommittee and Staff recommend approval.


